## Trees Atlanta and Friends of Bitsy Grant Tennis Become Partners

On Thursday, December 4, the weather was windy, cold and rainy, but nothing could dampen the spirits of the players at Bitsy Grant Tennis Center. This day they gathered outside to memorialize "The Tree," Bitsy's best-known landmark. Her life had ended in August when drought, disease, and a thunderstorm combined to send her crashing to the ground. The Tree was the only fully grown hardwood on the Bitsy premises capable of affording shade. Over the course of fifty-plus years, she attained legendary status. Here players would bring lawn chairs and libations to cool down after a hot match on the courts. Under her limbs, oral tennis history, often embellished, flourished.

But the gathering on December 4 was a time when the players, about 50 in number and mostly seniors, remembered the past and celebrated the future. Stan Smith, Jr., legal counsel for ALTA, spoke of his father, Stan, Sr., and his devotion to "The Tree Bar." Upon Stan's death several years ago, the players placed a concrete table and bench under The Tree in his memory. Luckily these were not hit when The Tree fell. The ceremonies concluded with recollections by Peter Howell and Dan Lyon, former presidents of Bitsy's tennis association.

Through efforts by Ann DeRosa, a partnership between Trees Atlanta and Friends of Bitsy Grant Tennis has been forged. As a result, Trees Atlanta donated a 15-foot, 6-inch caliper white oak to plant in the same spot where The Tree had been. Transportation costs to move the new tree from its original site were covered by "passing the hat" among the players and contributions from the Friends of Bitsy Grant Tennis Center. Ann DeRosa and Mike Maxwell spearheaded this drive.

Special guests for the day were Marcia Bansley, executive director of Trees Atlanta, and her staff. In addition to the replacement tree, four special saplings provided by Trees Atlanta were dedicated in memory of players Cliff Sheffield, Jim Hines, Scott Bridges, and Christine Butler. An additional twenty trees were planted around the property by Trees Atlanta.

Barbara Howell, fundraiser for Friends, introduced a Legacy Plan, which will allow contributors to work with Friends to remember Bitsy in their wills. For information, go to [www.bitsytennis.com](http://www.bitsytennis.com).

The day concluded with hot dogs and hot chili on the clubhouse porch, prepared by "Mama Ann" DeRosa. Overall the event was quite an auspicious beginning for "The Tree Deuce."

This is the first GA State Championship to be played at Bitsy Grant since the GA State Senior Championship in 2001, sponsored by the GA Tennis Foundation. It is great to see Championship Tournaments return to Bitsy Grant which has a wonderful history dating to the US Clay Court Championships won by Tony Trabert in 1955.

This Tournament combines both the Men's and Women's Open events as well as the Senior (ages 30-85) events. Lately, they have been held at separate venues. **An Open Event means players from outside GA can compete. We look to full draws and urge everyone to participate.**

An extravagant **Gala** is planned in conjunction with the tournament, as well as a players' social. "We hope to set the standard by which other State Championships will be judged" stated Peter Howell, tournament director.
